जनप्रतिनिधित्व अधिनियम, 1951 की धारा 135-बी (मतदान के दिन कर्मचारियों को सर्वेतन अवकाश की मंजूरी) के अनुसार :-

- (1) किसी भी कारोबार, व्यवसाय, औद्योगिक उपक्रम या किसी अन्य स्थापन में नियोजित प्रत्येक व्यक्ति जो दिल्ली राष्ट्रीय राजधानी क्षेत्र की यिधान सभा के लिए निर्वाचन में मतदान करने का हकदार है, उसे मतदान के दिन यानी 5 फरवरी 2025 (बुधवार) को अवकाश दिया जाएगा ताकि वह निर्वाचन में अपना मत डाल सके।
- (2) उपधारा (1) के अनुसार अवकाश मंजूर किए जाने के कारण किसी ऐसे व्यक्ति की मजदूरी से कोई कटौती या उसमें कोई कमी नहीं की जाएगी और यदि ऐसा व्यक्ति इस आधार पर नियोजित किया जाता है कि उसे सामान्यतया किसी ऐसे दिन के लिए मजदूरी प्राप्त नहीं होगी तो इस बात के होते हुए भी, उसे ऐसे दिन के लिए वह मजदूरी दी जाएगी, जो उस दिन उसे अवकाश मंजूर न किए जाने की दशा में दी गई होती।
- (3) यदि कोई नियोजक उपधारा (1) या उपधारा (2) के उपबंधों का उल्लंघन करेगा, तो ऐसा नियोजक जुर्माने से, जो पांच सौं रुपए तक का हो सकेगा, दंडनीय होगा।
- (4) यह धारा किसी ऐसे निर्वाचक को लागू नहीं होगी जिसकी अनुपस्थिति से उस नियोजन के संबंध में जिसमें वह लगा हुआ है, कोई खतरा या भारी क्षति हो सकती है।

उपर्युक्त प्रावधानों के अनुसार सभी मतदाताओं को, जो शिफ्ट आधार पर काम करने वाले स्थापन और दुकानों के कर्मचारी हैं, उस निर्वाचन क्षेत्र में मतदान के दिन सवेतन अवकाश प्रदान किया जाएगा जहां विधान सभा के लिए आम चुनाव होने हैं। इसके अलावा, ऐसे मामले भी हो सकते हैं जहां कोई व्यक्ति सामान्य रूप से निर्वाचन क्षेत्र का निवासी है और मतदाता के रूप में पंजीकृत है, वह आम चुनाव वाले निर्वाचन क्षेत्र के बाहर स्थित किसी औद्योगिक उपक्रम या स्थापन में सेवारत या नियोजित हो सकता है। यह स्पष्ट किया जाता है कि ऐसी स्थित में, संबंधित निर्वाचन क्षेत्र के बाहर काम करने वाले आकस्मिक श्रमिकों सहित वे मतदाता भी जनप्रतिनिधित्व अधिनियम, 1951 की धारा 135 बी (1) के अंतर्गत सवेतन अवकाश का लाभ पाने के हकदार होंगे। दैनिक वेतन भोगी/आकस्मिक कर्मचारी भी जनप्रतिनिधित्व अधिनियम, 1951 की धारा 135 बी दिए गए प्रावधान के अनुसार मतदान के दिन सवेतन अवकाश के अधिकारी हैं।

PUBLIC NOTICE

As per Section 135-B of the Representation of the People Act, 1951 (Grant of paid holiday to employees on the day of poll):-

- Every person employed in any business, trade, industrial undertaking or any other establishment and entitled to vote at an election to the Legislative Assembly of NCT of Delhi shall be granted a holiday, on the day of poll i.e. 5th February 2025 (Wednesday) so that he/she can cast his/her vote in the election.
- 2. No deduction or abatement of the wages of any such person shall be made on account of a holiday having been granted in accordance with sub-section (1) and if such person is employed on the basis that he/she would not ordinarily receive wages for such a day, she/he shall nonetheless be paid for such day the wages he/she would have drawn had not a holiday been granted to him/her on that day.
- If an employer contravenes the provisions of sub-section (1) or sub-section (2), then such employer shall be punishable with fine, which may extend to five hundred rupees.
- This section shall not apply to any elector whose absence may cause danger or substantial loss in respect of the employment in which he/she is engaged.

The above provisions require that all the electors who are employee of establishments and shops including those which work on shift basis shall be granted a Paid Holiday on the day of poll in the Constituency where the General Election to Legislative Assembly is to be held. Further, there may be cases where a person is ordinarily a resident of the Constituency and registered as an elector, may be serving or employed in an industrial undertaking or an establishment located outside the Constituency having General poll. It is clarified that in such a situation, even those electors including casual workers working outside the constituency concerned would be entitled to the benefit of a paid holiday extended under the Section 135B (1) of the Representation of the People Act, 1951. The daily wage/casual workers are also entitled for a holiday and wages on poll day as provided in Section 135B of the R.P. Act, 1951.
